## New Rules for Bowling

If you holler "overs!" before the ball passes the arrows, you get to throw the ball over, unless of course, you get a strike. In which case, you can renege on the "overs".

When your team is about 10 marks down in the 8th or 9th frame, you can invoke the rule "First Team Through Bowling Wins the Game", and your team still has a chance.

After a member of the opposing team bowls 4 strikes in a row, he/she must bowl the next 4 frames blindfolded. If he/she continues to strike, his/her shoelaces will be tied together for 2 frames.

When you leave the 10-pin and you know you can't make the spare, but another member of your team can, invoke the "Designated Bowler" rule.

After you have 4 splits in one game, you may say "Kings X" and take those 4 frames over. However, if you split on the 2nd time around, you accept it. After all, "Fair is Fair".

If your ball goes in the gutter and jumps back onto the lane, knocking down pins, by golly, you get them! That's much harder than to knock them down the conventional way. Good bowling should be recognized.

A ball should be declared dead when you bowl 3 games without a strike. It shall be the owners privilege to decide on the disposition of said dead ball - Burial at Sea, Dropped from an airplane over a live volcano, or a simple burial in the city dump. For a small fee, a league officer can be bribed to deliver a short eulogy.

## High School Bowling...Deep in our Hearts and in Texas

High School sports, especially in a state like Texas, can be all blood and guts and winning at all costs. And don't get us wrong, we love to win, but here the competitors practice together. And how many athletes say, "My Grandpa has always done it and I wanted to do something I could do with my family" when they talk about their sport?

It's Friday night at Phantom Warrior Lanes at Fort Hood, Texas and two young men are bowling on lanes 41 and 42. Jon Orallo, a freshman at Shoemaker High School and Andrew Esplana, a senior at Copperas Cove High, are rivals in the Central Texas District and part of the three-year-old high school bowling program that has grown significantly each year.

Jon said he tried out for bowling because, "I love bowling and Grandpa loves it, too and he loves to watch me bowl. It gives me something I can do with my family." Jon heard of the tryouts and when the smoke cleared, he was selected for the varsity team. Bowling fit right in to Jon's busy schedule of school, Law Enforcement Explorers and many church activities.

"I have bowled all my life," Andrew said. "I was either in a garage or a bowling center. I heard about the high school bowling program since I was a freshman, but we didn't have a coach or program until I was a senior. Once I heard we had it, I tried out and made the team." Andrew, raised in a military family, has bowled in Guam, Korea, Hawaii and the States and is involved in paint ball and martial arts. His goal is to attend Texas

A&M and get commissioned as an officer in the Army.

Practicing across town at Hallmark Lanes was Adrienne Nash, a junior as Shoemaker who has been bowling for about 11 years. She loves the competition and says, "Bowling is like soccer. The kids know it's there but don't know much about it." Adrienne, a 3.50 GPA student, hopes to get a college bowling scholarship and ultimately become a pharmacist.

Brian Wallace, a junior, has only been bowling for four years and carries a 184 average. The smooth stroker is quick to give credit to his high school coaches. "My coaches taught me well," he says. So well, Brian captured first place in division 11 singles and all-events during the 2002 Texas State YABA tournament and in 2003 again took first place in division 9 and finished third in all-events. The 3.75 GPA student adds, "Bowling is fund. With all the stress of school, this is really fun."

On the other side of town at Killeen Bowlerama, Heather King, a senior at Harker Heights High School, was practicing with her team for an upcoming competition.

Heather has been bowling for 15 years and competes in adult/youth leagues. Carrying a 175 average, she has captained the Harker Heights Lady Knights varsity bowling team since it began and led them to the 2002 state championship in the inaugural year of high school bowling. She is a senior and ranked in the top 10 percent of her class, and has been a member of the National Honor Society since her sophomore year.

where her mother and stepfather are the proprietors. "It was just natural for me to join the high school team. I've bowled all my life. I played high school volleyball, but it didn't really fit into my schedule well."

Her goals are to attend Central Texas College and transfer to Baylor University.

Kenny Lezo, the high school top gun, is a junior at Copperas Cove High School and is a golfer on the high school team. Bowling for 10 years, he started out in YABA, rolls in an adult/youth league, and when he heard about the high school program, jumped at the chance to compete.

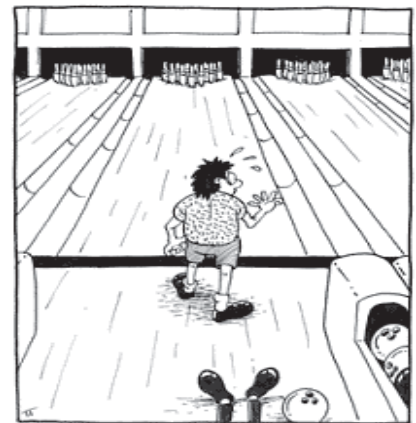
"I have a lot of friends who bowl and I really like the competition," Kenny said. And, compete he does. He carries a 187 average, has a high game of 279 that he has rolled five times, and a high series of 721.

Kenny is part of the Copperas Cove High School gifted and talented program and hopes to get a bowling or golf scholarship and major in business. "My Mom and I have been talking and we want to open a restaurant in Baghdad," he quipped.

The first high school bowling competition in Texas was held on December 13, 2001. Since that time the program has grown each year. More than 125 schools participated in the 2002-2003 season.

This year, 92 boys and girls teams from all districts competed at the state level. The districts include Central Texas, Comal Co., Dallas North, Dallas West, Fort Worth South, Fort Worth North, Galveston Co., Houston North, Houston NW, Houston SW, Montgomery County/Huntsville, North Texas, and Wichita Co.

In a state where football rules, Texas high school bowling is strong and these young athletes are smart, articulate and goal-oriented. Talking to them, you know not only is the future of bowling strong, but so is the future of America.



## You can't keep this good woman of the lanes down

1st Place - Senior Story

Adversity was met, and the future of Phyllis Scalia was brighter because of her determination and dauntless dedication to bowling. Now the Greater Joliet Area senior queen of bowling for the second straight year, Scalia had dedicated countless physical setbacks to gain her place in her beloved bowling.

Witness: The last 12 years have seen multiple surgeries, blocked arteries of heart (triple bypass), three times in her leg, and the carotid vessel in the neck. Each time even after 3½ months of hospitalization, saw her fight back to bowling. "After all," she explained, "it keeps me busy. I don't bowl to rule or reign, but to be with the people, I enjoy being there so much."

That hospital sojourn followed the worst Scalia case. The leg artery ruptured, an emergency situation for her lungs and kidneys shut down, dialysis necessary. After her return home, a triple-bypass of her heart was performed a month later. No bowling for several years.

"My doctors told me after the first leg bypass surgery, I would never walk again. I took three months of rehab, and then I said the hell with that." Meaning, the Scalia defiance saw her become a "home student" of personal therapy. Her personal rehabilitation consists of five times a week - a half-hour of exercise following a tape recording, then hours on the treadmill, stationary bike and the rowing machine.

In the words of devoted husband Joe, "It may have taken awhile for her to recover, but that didn't phase her." Twice more the leg artery needed opening, a stent was inserted the last time, and a "redo" of the heart operation.

Does all that impair her bowling? Scar tissue makes it difficult at times, but then there's that indomitableness. Were any of these trials and tribulations told by Phyllis? Almost all the facts given were

related by Joe, who isn't her better half, but rather a part of her. It's obvious at the lanes: He totes (and clean) her bowling equipment, watches, and advises about every ball she rolls. She credits his help for improvement, and in an aside, "Sometimes enough is enough - I can figure out solutions myself sometimes!" He tallies her team's scores, helps others to straighten out scorekeeping. And helps this league secretary of her Tuesday morning Carillon Doubles league with the standings, the game pots and more.

The bowling enjoyment of Phyllis Scalia is obvious, for she competes five times a week at home Strike 'n Spare II. Also with the doubles, there's the "Every Other Sunday" Carillon Mixed circuit, on Monday with the complimentary senior session, the Thursday Seniors, Friday with 9-pin No-Tap Seniors competition. And, she leads all the senior women there in average, series and games. Career highs were in the 2003-04 season, a 181 average, a 647 series and 259 game.

Born and raised in Chicago, her father, a fine bowler himself, got her interested in the sport she loves so much. In Chicago she competed at Lynwood Lanes, after graduation from Sacred Heart High School. She formerly worked as a cashier. The Joe surveillance began after they met at high school parties. They have two sons, Philip and Joe Jr., who don't bowl. But their grandson, Tony, is doted on. The Scalias have lived in the Carillon community, but Joe picks up Tony in Downers Grove to bring him to his Strike 'n Spare league session. Tony loves bowling too, has worked up in his two years of participation, to a 145 average. No, grandpa Joe doesn't bowl, his fine kegging days forgone because of arthritis.

Other Phyllis devotion, collections other than acquiring bowling awards? Joe was asked. "She collects everything she can Italian. No that's not her nationality, she is of German and Bohemian descent. But her example of determination, dedication and plain butts is a legacy."

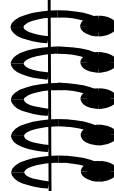
